- b)** In case of authorized dealer, Bidder should submit previous purchase order copies of supply of FELUWA make pumps or its spares supplied to any of the company during the last 05 years ending up to last date of previous month on which tender is floated along with part-1 of their offer, failing which their offer shall be rejected.
