#### **Additional terms & conditions.**

- 1) **Scope of Supply:** Supply of High Rate Thickener with accessories as per attached technical specification at our Jaduguda site. Jaduguda is located 25 M (approx. From Tata Nagar Railway station. )
- 2) Bidders shall submit their offer strictly as per specification and Scope given in the bid, Bidders shall also comply additional specification (if any) given in the bid, failing which offer will liable to be rejected. Conditional offer will also liable to be rejected.
- 3) **Related Party Clause:** Subsequent to bid opening, if it is found that bids submitted by related parties in which there seems to be collusion are liable to be rejected. Parties are considered to be related if one party has ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.

#### 6) **Important Instructions:-**

The tenderer must visit and see the area and work involved before submitting the offer.

Conical shaped bottom of the thickener will have an edge over the flat bottom when considered for inside hold up material.

The tenderer has to bring all the tools and tackles for erection job. However, water and electricity may be provided by the purchaser free of cost at one point only. If available 8 MT capacity mobile crane may be provided on chargeable basis.

Any other facilities if required by the Contractor shall be arranged by them and clearly mentioned in

n the offer. However tenderer should be ready to make their own arrangement for any of the facilities asked for which the purchaser is not in a position to provide.

The tenderer has to give guarantee for the equipment and accessories supplied for one year after commissioning, erection & no load test or 18 months from the date of supply (if UCIL fails to provide space for erection of the same within the time frame as mentioned in P.O.) whichever is earlier.

The offer must contain the following details:-

1. Detail drawings of rake, thickener; feed well, civil foundation & other accessories along with its dimensions.
2. Thickness of the plate, angles, pipes, beams etc. used for the construction purpose of the thickener, supporting structures etc.
3. Designed torque considered for the rake, rake drives mechanism etc. and torque rating offered with the equipment.
4. Details of gear boxes, motors, instruments along with details catalogue from the Manufacturers.
5. Details of bearing used in the drive mechanism including its make.
6. Weight of the empty thickener, accessories, drive mechanism & rake separately.
7. Offer shall be submitted in two parts in separate sealed and duly super scribed envelope. Part-I containing technical part and commercial terms having un-priced Price bid and Part-II containing Price only.

#### **8. FACILITIES TO BE EXTENDED BY UCIL**

- Water for leakage test of thickener shall be provided free of cost, from any nearby point within 50 mtrs of fabrication site. Party shall arrange for soft hoses for taking water up to work site.
- Power supply at a single point (415 V, 50Hz) within 30 mtrs of work site for welding machines, compressor, boiler, grinder etc. shall be provided free of cost. Party will have to fix up his own distribution board, cable, etc. Party shall get approved power distribution board arrangement from Chief Supt. (Electrical)/Mill, TMD.

#### **9. SCRAP REMOVAL**

Removal of all scraps separately to designated area within 500 meter range as directed by the Engineer-in-charge shall be in bidders scope.

#### **10. Note:**

- a. Supply of painting material, brush, wire brush etc. as per specification of painting is in bidder's scope.
- b. Party shall submit invoice copies for purchase of steel items, pipes, paints, electrodes from authorized dealers of specified make as per NIT.
- c. Fabrication scrap and unused balance material will be the property of the corporation.
- d. Successful bidder shall submit program (bar chart) for completion of the work and get it approved from Engineer-in-charge within 15 days from the date of receipt of purchase order
- e. Material is required to be supplied on FOR-destination basis duly unloaded & insured basis.
- f. The bidder shall fill the Price Breakup of unit rate in excel sheet (Annexure 'X') as given with GeM bid. Then bidder shall take printout & after signing this hard copy duly filled, upload its scan copy as financial bid document for Price Breakup submission of unit rate in financial bid of GeM portal only. (Not to be uploaded in technical bid).
- g. The bidder shall quote the same Total landed cost quoted in quoting unit price of item in GeM.

#### **11. GENERAL SAFETY GUIDELINES TO BE FOLLOWED:**

- a. The contractor shall train and build up a general awareness in safety among the workers and staffs as a continuous effort throughout the contract duration. He shall develop and nurture a good safety culture

e among the staff and workers for an incident free completion of the work order.

b. Safety Induction Training: The contractor shall ensure that each and every new worker attends initial safety induction training before reporting at respective place of work. The workers shall report to the safety officer first for receiving safety induction training and after successful completion of such training they shall report to respective site engineer. The safety officer shall intimate the workers about the probable hazards related to the work and shall explain and demonstrate the importance and use of PPEs to them.

c. Pep talk, Tool box training: Subsequent to the initial safety induction training, the contractor site supervisor shall also conduct safety pep talks and tool box training for various teams of workers in regular interval at site. He shall arrange pep talks / tool box training on work related topics like use of various PPEs and tools, housekeeping, hot job, electrical works, etc. He shall solicit active participation of workers in such tool box training by asking them to share their experience with their fellow workers.

d. All necessary personal safety equipment as considered adequate by the Engineer-in-Charge should be kept available for the use of the person employed on the site and maintained in a condition suitable for immediate use, and the contractor should take adequate steps to ensure proper use of equipment by those concerned.

e. All persons employed or supervising at and / or visiting the construction site shall use safety helmets. The colour coding of helmets may be adopted by the contractor as per site requirement. The contractor shall provide safety shoes for all his workers, supervisors, staffs and visitor/visiting staffs.

f. Persons engaged in welding and gas cutting works shall use appropriate welding face shields, leather hand gloves and protective clothes. The persons who assist the welders shall use appropriate goggles.

g. Persons working at height above ground level or floor and exposed to risk of falling down shall use full harness safety belts, kinetic shock absorbers, fall arrestor, life lines, and grab ropes. The working platform and access shall be protected by cages, guard railings, etc. The area beneath shall be protected by safety net of adequate strength (as per IS: 11057 – 1984) fastened to substantial supports.

## 12. GUARANTEE

All scope of item/equipment shall be guaranteed by the Bidder for a period of one year after being placed into service or (18) months from the date of shipment whichever is earlier, against defective materials, poor workmanship, improper design and failure from normal use. The Bidder shall replace, without charge, any item/equipment found defective within this period.

## 13. TERMS OF PAYMENT

1. 80% payment of design & Engg. and supply of equipments along with accessories shall be made on receipt and acceptance of goods by the UCIL at destination and on production of all required documents by the supplier and 5% of design & Engg. and product cost shall be allocated for ICT.

2. 20% payment of the cost of design & Engg. and supply of equipments along with accessories and balance payment of the cost of erection and commissioning shall be made on successful installation, commissioning and acceptance by the UCIL.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
