If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

  3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### PRE-QUALIFICATION CRITERIA:

i) **The Tenderer who wish to participate in the Tender shall fulfill the following Qualifying Criteria. Our requirement is 12 mandays per day. Contractor should upload documents as per checklist.**

#### a) Experience Criteria

Experience of having successfully completed similar jobs during last 07 years ending last day of month previous to the one in which tenders are invited should be either of the following: - **Similar Work means** "Supply of manpower for cleaning of spillage material or any other job which involves manpower supply".

Three similar works each costing not less than the amount equal to Rs. 14.18 Lakh

or

Two similar works each costing not less than the amount equal to Rs. 17.73 Lakh

or

One similar work costing not less than the amount equal to Rs. 28.36 Lakh

### **a) Financial Criteria**

- i) Average annual financial turnover during the last 03 (three) years, ending on 31<sup>st</sup> March of the financial year 2022-2023, should not be less than Rs. 10.64 Lakh.

The bidder shall submit documentary evidence in the form of copies of similar work order or completion certificate, audited balance sheet having profit and loss statement, PF Registration, GST registration; PAN Card & necessary undertaking etc. along with bid, failing which tenderer will be disqualified. If any bidder does not submit the Turnover value for any of the 3 years, the bidder will not disqualify and instead shall consider all the 3 years for computing the average, assuming a value of "zero" for the year for which no information has been furnished by the bidder.

This is a zero-deviation tender; hence tender with deviation (Non acceptance of terms and condition of tender) will be rejected.

### **GEOGRAPHIC PRESENCE:**

Office registration certificate: Registered Office or at least one of the Registered Branch Office of the bidder shall be located and registered within the geographical limits of the Andhrapradesh where the services needed to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.

- i. Trade License issued by the local authority in the name of the Firm or
- ii. Landline phone number in the name of the Firm or
- iii. Electricity bill for last one year in the name of the Firm or
- iv. GSTIN registration or

8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
