QUALIFICATION OF TENDERERS & DEFINITION OF SIMILAR WORKS MEANS

Evaluation will be done based on the documents submitted by the tenderers. No correspondence shall be made after opening of technical part regarding any missing document. Only such firms need tender who can produce satisfactory evidence that they have the necessary experience & financial resources and organization to undertake such work as per criteria mentioned below.

i) The Tenderer's average annual turnover for the work during last 03 years, ending 31st March of the previous financial year, should be at least 30% of estimated value i e. 10.37 Lakhs in Audited balance sheet & profit & loss account of each year must be submitted by the tenderer

ii) Experience of having successfully completed for " Manpower supply". during last 07 years ending last day of month previous to the one in which application are invited should be either of the following

One single similar completed job costing not less than 80% of estimated value i e. 27.64 Lakhs or

Two similar completed jobs costing not less than 50% of estimated value each i e. 17.28 Lakhs or

Three similar completed jobs costing not less than 40% of estimated value each i.e. 13.82 Lakhs

SIMILAR WORK Party should have experience of for "Manpower supply". The contractor will have to submit copy of the work order as well as the completion certificate from the concern department in support of their experience/ credential.

GEOGRAPHIC PRESENCE OFFICE REGISTRATION CERTIFICATE: Registered office or at least one of the registered branch office of the bidder shall be located and registered within the geographical limits of Jharkhand state where the services need to be provided. Documentary evidence must be provided in the form of Municipality trade licence or other such documents as per the following which satisfies as a proof of having the office establishment.

a) Trade licence issue by the local authority in the name of the Firm or b) Landline phone number in the name of the Firm or

c) Electricity bill for last one year in the name of the Firm or

d) GSTIN registration or

e) Udyam /MSME /Udyog Aadhaar certificate.

Note: Cost of Reimbursement for Medical, PPE, Tools & Tackles, Uniforms comes to Rs. 5000.00/manpower/year on production of Original bill. So, Total cost of reimbursement comes to Rs. 5000.00 x 8.00 (Manpower) x 02 years = Rs. 80000.00

2. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of URANIUM CORPORATION OF INDIA LIMITED payable at SBI, JADUGUDA. Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

3. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of URANIUM CORPORATION OF INDIA LIMITED payable at SBI, JADUGUDA. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

Disclaimer

Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the [General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
