1. Generic

The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

4. **Buyer Added Bid Specific Scope Of Work(SOW)**

Text Clause(s)

1.0 SCOPE OF WORK

Miscellaneous Underground Electrical Works at Mohuldih Mine includes all the electrical installations available at the Mohuldih Mine like maintenance of Drill jumbo panels, Gate-End-Box, Starters of fan and pumps, substations, HT, LT switchgears, PDB's, transformers and any other equipments and areas not mentioned in the tender but instructed by engineer in charge or his representative comes under the scope of work.

2.0 TECHNICAL SPECIFICATIONS

It will be the **responsibility of the contractor** to work as per the technical specifications given in the following paragraphs and SOP (Safe Operating Procedure) provided.

2.1 Introduction

2.1.1 Location

Mohuldih Mine is located in Singhbhum thrust belt of Jharkhand with latitude $22^{\circ} 44'$ N and longitude $86^{\circ} 08'$ E. It is situated about 28 Km west of Jaduguda and about 7 Km south of Tatanagar Railway Station.

2.1.2 Geology

The area belongs to the Singhbhum shear zone and in this zone the shear passes through the Iron Ore Stage of rock and run nearly East-West. The Uranium occur mainly in two parallel bands, the hangwall (HW) lode is hosted by tourmaline - bearing quartz sericite whereas the footwall (FW) lode is associated with magnetite-bearing quartzite. These are overlain by chlorite schist, which is the westerly extension of the Turamdih - Keruadungri horizon and it hosts subsidiary Uranium mineralization, in the form of auxiliary lode. The mineralization is mostly in the form of uranium (U_3O_8), and the associated minerals are apatite and tourmaline.

2.2 Work Procedure: All works shall be done as per SOP of Mohuldih Mine and this SOP will be provided by the engineer in charge or his Representative under the guidance of electrical supervisor. The Tenderer are advised to visit the site to acquaint themselves as to the nature and location of the work, the general and local conditions particularly those bearing upon transportation, physical condition of the site, conditions of the ground, quality and quantity of surface to be encountered, the character of equipment and facilities needed preliminary to and during the progress of the work, and all other matters which can be of, in any way affect the work the cost thereof under the contract. Tenderer must have qualified persons with full knowledge and experience to carry out these jobs.

3.0 Procedure for Receiving Free Issue Materials

All the materials which are to be supplied free of cost to the contractor and required for immediate use /consumption will be provided at Mohuldih work site once in a day on working days only, during the scheduled hours fixed by UCIL.

The contractor will have to maintain a register of receipt and consumption of materials issued free of cost to him. He has to submit monthly comprehensive statements of all the materials issued to him and should get it certified by the engineer-in-charge.

3.1 Site Organisational Structure

The name and designation of the officer-in-charge appointed by the tenderer to do all technical /statutory co-ordinations at the site or elsewhere and to whom all references shall be made is to be declared by the tenderer in writing before the issue of the letter of intent.

Before the commencement of any site work as well as wherever there is any change, the contractor has to submit in writing to the Engineer-in Charge, the organisational structure of the site manpower deployed by him.

3.2 Safety, Environment and Laws of the Land

3.2.1 The contractor shall ensure that all work /activities are carried out without any prejudice to any law of the country, which is in force or may come into force in future. The contractor should fulfil all the statutory conditions timely as may be applicable to the area where it is operating.

3.2.2 The contractor should take care to maintain a healthy environmental condition and also maintain good housekeeping of the area under its control.

3.3 Procedure for Engaging Persons as per this Tender

3.3.1 **All persons** before their actual engagement in any work **will have to be medically examined** and in case found to be medically fit will be considered for engagement.

3.3.2 The names and other particulars of all the persons employed as per this tender will have to be entered in the A-Register of the mine before they are deployed in any job. For entering their names in to the A-Registers, the following documents will be required.

- (i) Proof of Medical Fitness in the prescribed format.
- (ii) Proof of Date of Birth.
- (iii) Identification Proof / Aadhar Card.
- (iv) Police verification for gate pass.

3.3.3 **All the persons** who are required **to be imparted vocational training** under the Mines Vocational Rules, 1966 will have to be imparted vocational training at the Group VTC, Narwapahar **before engaging them in the actual operations.**

3.3.4 The **contractor will issue photo identity cards** to each person and this has to be shown to the security agencies at the Mines Gate whenever he is required to enter the mines premises.

- 3.3.5 The contractor will also **submit to the Mohuldih Mines Gate In-Charge a list of persons engaged** by him. He has to update this list as and when any person is employed newly or is terminated from the work.
- 3.3.6 The engagement of all the persons will be provisional and subject to police verification of the credentials of the person.
- 3.3.7 The tenderer has to supply **Six nos. of Skilled Electrician** having ITI certificate from recognized Institution / Wireman certificate from competent authority and minimum five years of experience in electrical field and **Two nos. of semi-skilled Electrician** having ITI certificate from recognized Institution / Wireman certificate from competent authority and minimum two years of experience in electrical field. Candidates having higher qualification than required will also be considered subject to interview by the electrical team.
- 3.3.8 For above manpower deployment contractor has to take **insurance and license of 08 work persons** and maintain on roll to execute the work.

3.4 Security, Law & Order

- 3.4.1 The safety and security of all the materials stored at the site, all installations and of the persons employed by the contractor will be the responsibility of the contractor.
- 3.4.2 **The contractor will manage and handle all the security and local problems** affecting the execution of its work.
- 3.4.3 While recruiting any person to work in any position under this contract, **the local people should be taken into confidence**. Selection of such persons from places outside the local area should be done only when persons from local area who are capable of executing the desired work are not available.

3.5 General

- 3.5.1 Accommodation of the entire employees, supervisors etc. deployed by the contractor will be the responsibility of the contractor. No space will be given to the contractor anywhere within the mine premises for accommodating any of these persons.
- 3.5.2 All the work to be executed by the contractor shall be as per the drawing, document, instruction provided by UCIL.
- 3.5.3 All activities, materials, equipment, spares, consumables, labour, tools, tackles, irrespective of whether stated or indicated anywhere in the tender document or not, but required for ensuring the proper quality of the work or to meet any statutory requirement or for the proper completion of the work, will be in the scope of the contractor and he will have to execute it.
- The rates for the items that could not be envisaged /predicted at the time of award of the contract, but required to be executed for the completion of the work, shall be computed at the mutually agreed rate.
- 3.5.4 All jobs /work of contractor will be examined by our supervisors /engineers and other managerial

staff for quality, safety other statutory requirement and their progress.

- 3.5.5 It will be the responsibility of the contractor to ensure that all documents, property of UCIL handled by the staff engaged by him are in safe custody at all times.
- 3.5.6 The contractor shall ensure that all the persons appointed by him always maintain proper official decorum; punctuality, privacy and official secrecy as far as their allocated work is concerned.
- 3.5.7 Providing Personal Protective Equipment (PPE) to the workman will be supplied by the contractor as per requirement.
- 3.5.8 Cap lamps of required nos. will be supplied by the corporation free of cost on day to day on returnable basis.
- 3.5.9 You have to also submit PF challan copy of every month to the Personnel office/Mines Office, Turamdih and Mohuldih respectively.
- 3.5.10 **Bonus shall be paid to all the work persons by the contractor on monthly basis.**
- 3.5.11 Monthly R.A bill and one final bill will be paid for this work.
- 3.5.12 In case of stoppage of work by local people / bandh or any other reason, no idle charge will be paid by the corporation towards labour, plant & machinery etc. to the contractor.
- 3.5.13 All tools and tackles will be provided by the contractor as per the list enclosed. Also the tools will be retained by the corporation. The amount of tools will be reimbursed as per actual bill submitted by the contractor.
- 3.5.14 The works have to be carried out in running mine in A,B&C shifts and the contractor will be governed by the rules and regulations of mine workings and labour laws.
- 3.5.15 The minimum wages to labours will be fixed by ALC; Chaibasa from time to time for underground work to be paid by the contractor to the workmen engaged for this work and should maintain all registers/documents etc. as per Mines Act 1952 and labour laws.
- 3.5.16 The works have to carried out as per the provision of Mines Act 1952, Mine Rule 1955, Metalliferous Mine regulation 1961, CEAR Act (Electricity Act), Minimum wages Act and rules, contractor labour (regulations and abolition) Act 1970 with contract rules 1971 and all other laws applicable to metal mines in regard to the works awarded.
- 3.5.17 All the works shall be executed as per existing site conditions and no extra claims shall be entertained.
- 3.5.18 Contractor has to follow safety guidelines / SOP for works contract as per AERB and DGMS.

4.0 WORK SCHEDULE

The work will have to be completed within a period of **12 months**. The work will have to be carried out round the clock in three shifts (A, B & C shifts) on all working days (**except rest day**). They may be called on Sunday or holidays also as per the instruction of engineer in charge.

5.0 DEFECT LIABILITY PERIOD

There will be no defect liability period for this contract.

6.0 TAXES

The Contractor shall include all the prevailing taxes like GST, duties etc. If there is an increase/decrease in GST & other statutory taxes etc. after the opening of the price bid, UCIL shall reimburse/recover the amount on submission of documentary proof.

7.0 SECURITY DEPOSIT

The security deposit for this tender with earnest money will be **3% of the value of the contract**. **1.5%** shall be submitted in form of 'demand draft' or 'bankers cheque' or 'BG' from Nationalized bank / Scheduled Commercial bank and rest 1.5% shall be submitted from Monthly R.A bills. The **validity** of the '**demand draft**' or '**bankers cheque**' or **B.G** should be for a period of **18 months**.

8.0 EARNEST MONEY DEPOSIT (EMD)

- Earnest Money Deposit (EMD) is a deposit received from the tenderers in token of their earnestness in submitting their offer to undertake the supplies/works/services/consultancy contracts and conclude a contract if entrusted to them on the basis of their tender.
- The amount of EMD shall be a fixed sum based on estimated value as given below.
- EMD is to be remitted by way of 'demand draft' or 'bankers cheque' or 'BG' only in favour of Uranium Corporation of India Limited. No cash, MO, Fund Transfer etc is to be accepted.

- a. No interest is payable on the EMD.

9.1 EMD is liable to be forfeited if:

- a) The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the date of opening.
- b) The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
- c) In case bidder submits false/fabricated documents.
- d) In case bidder fails to submit Security Deposit within 30 days of receipt of

Work/Purchase Order.

- 9.2 Approval for exemption from remittance of EMD, if required shall be obtained prior to invitation of tender and the same to be notified in the tender document.
- 9.3 The offers received from tenderers without EMD and/or tender cost shall be summarily rejected except where exemption is provided in the tender.
- 9.4 Public Sector Undertakings, State Government Undertakings, may be exempted from payment of EMD with the approval of Competent Authority. **MSME / Small Scale Industries (SSI) / NSIC** with current valid registration with State or Central Govt. shall be exempted from payment of EMD (after ensuring that the registration in case of SSI) pertains to the class of items/stores/works for which the tender is floated) by the authority competent to conclude supply/ contract orders.
- 9.5 In specific tenders where there may not be good response or for any other reasons, EMD can be waived with prior approval of competent authority before finalization of tender.
- 9.6 EMD may be adjusted against security deposit of the successful bidder. EMD of unsuccessful bidders and successful bidder where SD is not applicable should be returned immediately once the L1 bidder is decided.
- 9.7 In case where the EMD is provided in form of BG in the prescribed format to be attached with the tender, the BG shall be obtained from a **Nationalized bank / Scheduled Commercial bank**. The genuineness of BG should be checked from the issuing bank.
- 9.8 In repetitive /routine works, Vendors may submit EMD in the form of Security Deposit. The vendors depositing security deposit EMD of Rs 50,000/- shall be allowed to quote any number of works for works upto Rs. 10 lacs and Vendors depositing Rs 1 lacs shall be allowed quote any number of works for works upto 20 lacs , without submission of EMD. The EMD exemption shall be allowed as long as SD remains with the UCIL. In case of default by the bidder (when L1 backs out) the 2 % of estimated cost shall be recovered from the security EMD lying with UCIL. In cases when L1 defaults in more than one works and when the recovery is more than SD, the recovery shall be effected from the other bills of the defaulter bidder. The vendors who don't want to submit Security Deposit shall also have an option of submitting work wise EMD @ 2 % of estimated cost.

10.0 PENALTY

If manpower supplied is below 5 without information of engineer in charge in writing in any working day then 10% penalty of absent person of that day will be deducted from the bill

For example: If 5 or above persons are available on any working day, penalty is nil.

If 4 or less person is available in any working day with information to the engineer in charge in writing then the penalty will be nil.

If 4 person is available in any working day without information of engineer in charge in writing then penalty will be (rate of 4 mandays) X0.10

If 3 person is available in any working day without information of engineer in charge in writing then penalty will be (rate of 5 mandays) X0.10 and so on.

11.0 Escalation:

Labour escalation (revised labour rate) will be given as per notification of UCIL from time to time. Labour escalation will be paid as per formula mentioned below:-

$$WEV = R \times (W1 - W0) \times 0.70 / W0$$

WEV = Wage Escalation Value

R = Original Awarded Value/ Work Done Value

W0 = Minimum Labour wages based on Govt. Notification as on the last date of submission of price bid or revised Price bid whichever is later.

W1 = Revised Minimum labour wages based on Govt. Notification during the period of Execution of work.

12.0 ANY CLAIM, REIMBURSEMENT ETC.

Any claim, reimbursement etc. falling out of the purview for which RA bills are paid will be put up to the General Manager (Mines). General Manager (Mines) will constitute a committee which will go through the above and give its recommendations. These recommendations with comments of Engineer-in-charge will be put up to Director (Tech.) for final decision.

- The estimate has been taken without profit. Tenderes are requested to check the value and include their profit in the bidding.
- Scope of work "Miscellaneous Underground Electrical Works at Mohuldih Mine" includes all the electrical installations available at the Mohuldih Mine like maintenance of Drill jumbo panels, Gate-End-Box, Starters of fan and pumps, substations, HT, LT switchgears, PDB's, transformers and any other equipments and areas not mentioned in the tender but instructed by engineer in charge or his representative comes under the scope of work.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

8. Seeking sample with bid or approval of samples during bid evaluation process.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
