- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. - 3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total OUANTITY.
- 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

The eligible criteria to qualify in Technical Part are as below:-

- 1. Average Annual financial turnover during the last 3 years, ending 31St March of the previous financial year/A.Y. should be at least 30% of the estimated cost i.e. **Rs 14.20** Lakhs
- 2. Experience of having successfully completed "Similar works" during last 07 years ending last day of month previous to t he one in which application are invited should be either of the following:
- a) Three Similar completed each works consisting not less than 40% of estimated Cost or the amount equal to Rs 18.93 Lakhs
- b) Two Similar completed each works consisting not less than **50%** of estimated Cost or to the amount equal to Rs **23.67** Lak hs or
- c) One Similar completed work consisting not less than 80% of estimated Cost or the amount equal to Rs. 37.87 Lakhs or
- 3. Tenderer must upload relevant work order & completion certificate against each work.
- 4. Similar works means : Repair/maintenance of bituminous roads, construction of bituminous roads shall be consi dered as similar work.
- 5. Bidders must attach Work done certificate mentioned executed amount and date of completion.
- 6. Similar works means "Repair/maintenance of bituminous roads, construction of bituminous roads shall be considered as similar work.
- 7. Necessary documentary evidences in support of the same in the form of copy of Work Orders & Completion Certificates f rom the competent authority of client, along with the contact details of the signatories shall be furnished, in absence of whi ch the offer will be rejected. Any other document / certified drawing as desired by UCIL, to assess the Similar Work shall have to submitted.
- 8. (A) Public Sector Undertakings, State Government Undertakings, may be exempted from payment of EMD with the approval of Competent Authority. MSME/Small Scale Industries (SSI) with current valid registration with State or Central Govt. shall be exempted from payment of EMD (after ensuring that the registration in case of SSI) pertains to the class of items/sto res/works for which the tender is floated) by the authority competent to conclude supply/ contract orders.

The tender documents shall be issued free of cost to company/units registered with MSME/National Small Industries Corpor ation/Director of Industries of State, Cottage Industries approved by the State Authority or any other entity as may be specified by Govt. guidelines from time to time, after ensuring that the approval pertains to the class of item/works for which tender is floated.

Benefit for MSME owned by SC/ST will be applicable as per the Govt. guide lines.

In case of Government undertaking / PSU, tender documents may be issued free of cost subject to approval of Competent Authority and it shall be mentioned in the tender document.

Pre-qualification criteria with respect to prior turnover and prior experience may be relaxed for micro and Small Enterprises as per GOI guidelines subject to meeting of quality and technical specification under start up Scheme as per Go vt. policy circular No. 1(2)(1)/2016-MA Dt. 10th March 2016 you have to submit NSIC certificate or other authentic relevant document to proof your capacity, quality and technical specification to qualify the technical part otherwise your tender will

be not considered.

- 8. (B) Cost of tender fee should be paid through SBI Collect Challan. This will operate at all branches of SBI in India. Form at of Challan (UCIL Copy) shall be uploaded in (**GEM Portal**) The cost of Tender may also be submitted in the form of DD in favour of Uranium Corporation of India Limited Only.
- 9. The tenders are to be uploaded (**GEM Portal**) on or before due date fixed for receiving the bid. Physical submission of tender shall not be accepted. Tenders received without original Earnest money deposit and cost of tender document shall be summarily rejected.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
