1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 4. i) The Tenderer's average annual turnover for the work during last 03 years, ending 31st March of the previous financial year, should be at least Rs. 3.02 Lakh in Audited balance sheet & profit & loss account of each year must be submitted by the tenderer

ii) Experience of having successfully completed for any Construction of civil work during last 07 years in which application are invited should be either of the following

a) One single similar completed job costing not less than Rs. 8.06 lakhs or

b) Two similar completed jobs costing not less than Rs. 5.04 lakhs each or

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to

such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
