PRE-QUALIFICATION CRITERIA (PQC)/ ELIGIBILITY CRITERIA

The followings are the Eligibility criteria for this Non-divisible service Contract. The bidder may visit the proposed work site to get well acquainted about the site work before filling the rate/submit the tender.

1. PAST PERFORMANCE AND PROJECT / PAST EXPERIENCE etc. CRITERIA:

1.0 The Bidder must have experience in repairing /manufacturing/Supplier of self starter or alternator in last Seven (07) years ending last day of months previous to the one in which applications are invited with Govt. / PSU / Public Limited Organization / Private Limited Organization.

2.0 Experience of having successfully completed similar works during current or last seven (07) years ending last day of month previous to the one in which applications are invited.

The "Similar Work" means Repairing /Manufacturing/Supplier of self starter or alternator

2. FINANCIAL STANDING:

Average annual financial turnover during the last three financial years should be at least 30% of the yearly estimated Cost (2.2 Lakh).

3. GSTIN copy, PAN copy must be submitted along with the bid.
4. Any bid not complying PQC requirements shall be summarily rejected.
5. EMD exemption only to relevant MSME/MSE.
6. Turnover exemption only for relevant Startups as per government guidelines.
