3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
4. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
5. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
6. Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar for that product category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.
7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. **1. Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

**ATC**

**1) Pre-Qualification Criteria (PQC):**

The Qualifying Criteria for this tender are as follows. The bids of tenderers which do not fulfil the Qualifying Criteria shall be summarily rejected.

**Experience Criteria**

Experience of having successfully completed similar works during last seven years ending last day of month previous to the one in which application are invited should be either of the following:-

- I. Three similar completed works each costing not less than the amount equal to **Rs.19.94**

- II. Two similar completed works each costing not less than the amount equal to **Rs.24.93** Lakhs.

- IV. Copy of completion/performance report from the organization where the relevant work is executed is to be enclosed. Submission of Work Order copy alone is not adequate. For the work executed (completed work) in UCIL the work Order copy is acceptable.

**2) SCOPE OF WORK :**

**The scope of work of this tender will be Construction / Repair / Maintenance of drains and other associated miscellaneous works at UCIL Tummalapalle area as per direction of Engineer-in-charge.**

The Contractor shall carry out and complete the said work in every respect in accordance with the Contract and with the direction of and to the satisfaction of the Corporation. The Corporation may in his absolute discretion and from time to time issue written instructions,

Details, directions and explanations, which are hereafter collectively referred to as UCIL's instructions in regard to:

1. The variation or modification of the design, quality or quantity of works or the addition or omission or substitution of any work.
2. Any discrepancy in the Schedule of Quantities and/or Specification.
3. The removal from the site of any material brought there on by the Contractor and the Substitution of any other material thereof.
4. The removal and/or re-execution of any works executed by the Contractor.
5. The dismissal of any person from works employed there upon.
6. Opening up for inspection of any work covered up.
7. Amending & making good of any defect.

### **3) Compensation for Delay :**

1. If the Contractor fails to maintain the required progress in terms of the condition of this contract or to complete the work and clear the site on or before the contract or extended date/period of completion, he shall, without prejudice to any other right or remedy of the Corporation on account of such breach, pay as agreed compensation amount calculated as stipulated below or such similar amount as the contract value of the work for every week that the progress remains below that specified or that the work remain incomplete.

This will also apply to items or group of items for which separate period of completion has been specified.

For this purpose the terms 'Contract Value' shall be the value at contract rates of the works as ordered

- (a) Completion period (as originally stipulated) : @ 1 percent

per week

not exceeding 6 months

(b) Completion period (as originally stipulated) : @ ½ percent per week

Exceeding 6 months and not exceeding 2 years

(c) Completion period (as originally stipulated) : @ ¼ percent per week

Exceeding 2 years

Providing always that the total amount of compensation for delays to be paid under this condition shall not exceed the under noted percentage of the contract value of the item or group of items of work for which a separate period of completion is given.

(a) Completion period (as originally stipulated) : 10 percent not exceeding 6 months

(b) Completion period (as originally stipulated) : 7 ½ percent Exceeding 6 months and not exceeding 2 years

(c) Completion period (as originally stipulated) : 5 percent Exceeding 2 years

The amount of compensation may be adjusted or set off against any sum payable to the Contractor under this or any other contract with the Corporation.

**4) Completion Period: 08(Eight) months** from the date of commencement of work. (Date of commencement of work will be reckoned 10 days after issue of written order or from the date of issue of work order).

**5) Security Deposit:** The Contractor shall permit the Corporation at the time or making any payment to him for work done under the Contract to deduct such sums as will along with the amount of the Earnest Money already deposited amount to 10% on the gross amount of bill till the sums and deducted amount to the figure shown in Schedule-F.

**6) Defects Liability Period: Six (04) months** from the date of handing over the site by Contractor after his rectifying all defects pointed out during joint inspection on virtual completion of the work. From commencement to completion of the works, the Contractor shall take full responsibility for the care thereof and for taking precaution to prevent loss or damage and to minimize, loss or damage to greatest extent possible and shall be liable for any damage or loss that may happen to the works or any part thereof and all government T & P from any cause whatsoever (save and except the Excepted Risks) and shall at his own cost repair and make good the same so

that at completion, the works and all Corporations T & P shall be in good order and conditions and in conformity in every respect with the requirements of contract and instructions of the Engineer-in-charge.

**7) Refund of Security Deposit:** 50% of total security deposit will be released after completion of the work and balance 50% after completion of defect liability period.

**8) Variation:** Any individual item may vary up to any extent subject to gross variation of maximum  $\pm 10\%$  (ten percent) of contract value. Contractor is liable to execute above variation at the same rate, terms and conditions stipulated in the contract.

**9) Extension:** Completion period of contract is **08(Eight) months** from the date of commencement. The tenure/period may be extended up to **03(three) months** (if the contract value is not consumed completely due to unforeseen reasons) further after completion of initial contract period with same rate, terms & conditions of the contract with mutual consent, if so deemed fit by UCIL and agreed by the contractor, as the nature of awarded work is as and when required basis and at discretion of the Engineer-in-charge.

**11) Escalation: No escalation will be paid for this work.**

**12) Payment terms:** Running bill can be raised on the progress. Payment shall be made within 30 days from date of certificate of bill by Engineer-in-charge after necessary recoveries.

**113) Agreement & Indemnity:** The tenderer shall execute the agreement & Indemnity with the UCIL in the proforma approved by the UCIL for the execution of the work, within 30(Thirty) days or as directed from the date of issue of letter of intent/ work order on non-judicial stamp paper of requisite value (min. of 100/-), which shall be provided by the tenderer at his own cost.

**14) Personal protective equipment:** All the required tools, tackles & safety items i.e helmet, gum boot/ safety shoes, hand gloves, dust mask, including tools and tackles etc. for this work is to be arranged by the contractor at his own cost. All workmen engaged must wear PPE's while at work.
