OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

1. PRE QUALIFICATION CRITERIA

A. Experience Criteria:

The bidder should have experience of having successfully executed any one criteria of similar works ("a" or "b" or "c") during last 07 years **ending with the last date of the previous month in which tender is floated to** any industry/ company as below:

- Single completed work order on "Descaling & Repairing any of mechanical equipments by Cold Welding Technique" for a value minimum of **Rs. 30,53,600/-**.
- Two completed work orders on "Descaling & repairing any of mechanical equipments by Cold Welding Technique", each having a value minimum of **Rs. 19,08,500/-**.
- Three completed work orders on "Descaling & Repairing of any of mechanical equipments by Cold Welding Technique", each having a value minimum of **Rs.15,26,800/-**.

(Supporting work orders and completed certificates should submit along with bid for fulfilling the technical criteria)

B. Financial Criteria

The bidder shall have minimum average annual turnover of Rs 12.00 lakh per year during last three financial years ending up to 31.03.2023 (i.e., FY2020-21, FY2021-22 & FY2022-23). Bidder shall submit signed copy of Audited Annual Financial Reports for last 3 (three) consecutive financial years ending 31st March 2023 (Balance Sheet and Profit & Loss Account). The signed Balance Sheet and Profit & Loss Account furnished by Bidders for financial eligibility should clearly indicate the details of the Membership No. & Firm No. of the Chartered Accountant and the UDIN.

This is a **public tender, two parts.**

2. ESSENTIAL TERMS AND CONDITIONS FOR SUBMITTING THE OFFER

1. Before submission of tender, the Tenderers are advised to make themselves fully conversant with the conditions of tendering, general conditions and Special conditions etc. They are also advised to physically visit the site to understand site working conditions, nature & modus operandi of jobs prior to quote for the same.
2. The Tenderer shall submit his tender strictly in accordance with the tender specification and terms & conditions laid down in the tender document. No tender will be accepted by Post / Courier.
3. By submitting a tender for the work in e-tender, a Tenderer will be deemed to have satisfied himself by actual inspection of the site and locality of the work, if so required and that the rates quoted by him in the tender will be adequate to complete the work in all respect according to the specification and other working conditions.
4. The Tenderer should mention their Price/ Item rates in figures as well as in words. In case of any dispute / ambiguity, the price/ rates mentioned in words shall be considered as final. No insertions, postscripts, additions and alterations shall be recognised unless confirmed by the Tenderer's signature.
5. Tender bids (Technical as well as price) shall be submitted strictly in a manner asked giving full details / information necessary for assessing their offer
6. Canvassing in any form is strictly prohibited and any Tenderer found to have resorted to canvassing or influencing other Tenderer shall be liable to have his tender rejected summarily.
7. Tender documents are not transferable.
8. ***The units registered under "Single Point Registration Scheme of NSIC"/ "MSME" are eligible to get the only benefit of issue of Tender document (if any) & EMD at free of cost. Bidders registered as manufacturers in the specific category items/ / Service providers in the mechanical repairing/ maintenances services on equipments" are only eligible for the benefit of issue of Tender document (if any) & EMD at free of cost.***
9. ***No Exemption has been given from submission of previous orders & financial criteria to any of MSME/NSIC bidders. All the bidders must submit the credentials to fulfill the mentioned Pre-Qualification criteria. Bidders who are failing in meeting the Pre-Qualification criteria will not be considered for next evaluation process.***

Special Note:

10. ***Any failure by the vendor/contractor to supply/execute the contract as per tender terms and conditions may result in black listing of respective vendor's /contractor for a period of 01 year or a period of minimum 01 year to maximum of 02 years.***
11. ***Also UCIL has the right to short close the order within the tenure, if the awarded bidder does n't obey/ execute the order as per tender terms and conditions (or) found in deviating any statutory compliance, with a prior notice of 10-15 days***

3. SCOPE OF WORK

The Descaling & Repairing of Spiral Heat Exchanger by Cold Welding Technique is related to our Autoclave equipments, i.e. Spiral Heat Exchangers. The scope of the work is mentioned below in detailed. All the jobs related this tender has to be done at UCIL works place. All the jobs regarding this tender are been

given on need basis as and when required depending on availability at site and contractor has to agree for the same. The Scope of work in each activity is briefly mentioned below.

Intimation to the Bidder will be given priorly before 02-03 days by over phone / E-mail for mobilizing required crew & other resources to attend the repairing jobs.

Scope of work of Bidder:

1. TO & FRO movement of Spiral Heat Exchanger (SHE) to repairing zone. UCIL will provide EOT Crane for transportation within autoclave area.
2. Opening of SHE end covers and examining thoroughly for any crack/hole formation on internal and external surfaces, or any scale formation in between various layers avoiding for the flow of material on the surfaces of Spiral heat exchangers.
3. Cleaning the heat exchanger both sides with high pressure water jet pumps (150-250 bar) and burning any plastic rubber tubes struck inside. Provision & maintenance of high pressure water jet pump is in the bidder's scope only.
4. Descaling /repairing process as per the instructions of Engineer -In-Charge using water/ de-floating chemicals (if required). However descaling agents like chemicals/Acid, are in the scope of Supplier only.
5. Party has to ensure complete cleaning in between the layers of SHE after removal of end covers before taking up for repairing.
6. Identifying holes with help of endoscopic cameras and water pressure test.
7. Patching the holes based on the size of hole diameter and depth from the opening. Preparing a patch material with DSS steel metal sheet as per requirement.
8. Creating perfect arrangements with cameras and patching glue and patching exactly on the hole. Use Brazing technique for minor size hole.
9. Box up of end covers and fixing and tightening of clamp bolts.
10. Hydro testing of Spiral heat exchange for any further leakages.
11. Supplier has to ensure no leakage from all over the periphery of Spiral heat exchanger before taking trail test ...
12. Trial run has to be taken to ensure for no leakage & Permissible DP values in the presence of M/s UCIL & bidder representatives...

Scope of work of M/s UCIL:

1. Providing of Electric Power for Motors (03 Phase) will be in UCIL Scope.
2. Providing of Water for Chemical circulation will be in UCIL Scope.
3. Providing of Helpers for opening & closing of doors will be in UCIL Scope.
4. Providing of welding services during chemical recirculation in-case of any requirement of new Pipe fittings are to be welded at the location.

Bid Rejection Criteria:

- a) Following bids shall be categorically rejected:
 - i) The bids received after Tender closing date and time.
 - ii) The bids received without EMD (Earnest Money Deposit) or Tender document fee..
- b) Following may render the bids liable for Rejection.
 - i) Bidder's failure to submit sufficient or complete details for evaluation of the bids within the given period.
 - ii) Bids with insufficient technical requirements and or terms not acceptable to UCIL.
 - iii) Validity period indicated by bidders is shorter than that specified in the tender enquiry.

4. The Bid Security will be forfeited:

- a) If any Bidder withdraws their bid during the period of bid validity (including any subsequent extension) specified by the Bidder on the Bid Form, or
- b) If a Successful Bidder fails:
 - i) To sign the contract within reasonable time and within the period of bid validity, and /or,
 - ii) To furnish Performance Security.
- c) If the Bidder furnished fraudulent document/information in their bid.

5. FURNISHING FRAUDULENT INFORMATION / DOCUMENT:

If it is found at any time that, a Bidder / Contractor has / had furnished fraudulent documents / info

ormation, the Bid Security / Performance Security shall be forfeited and the bidder /contractor shall be debarred for a period of two (02) years from the date of detection of such fraudulent act, besides legal action.

6. RATE (S) IN FIGURES AND WORDS:-

The tenderer should mention their price / item rates in figures as well as in words. In case of any dispute / ambiguity, the price / rate mentioned in words shall be considered as final. Insertions, postscripts, additions and alterations shall not be recognized unless confirmed by the tenderer's signature. **Tenderer shall quote rates(s) / price(s) on line in the price bid document (schedule of items and quantities) enclosed along with tender document. Otherwise, offers of parties quoting without this price format will be out rightly rejected.** The Tenderer shall quote the rates in figures and words will generate automatically.

7. TAXES & DUTIES:-

All Taxes including GST, service taxes, royalties, duties, octroi etc. and other taxes for execution the contract are to be specified clearly with in figures (or %) in the price bid. The final quoted rate should be inclusive of service tax /GST applicable at the time of tender submission.

The entire amount of service tax/GST will be recovered from the RA bill & deposited directly by UCIL, if applicable.

Any new taxes imposed by Govt/statutory authority during the contract or any increase of the existing taxes at any stage during execution of the contract shall be reimbursed to the contractor on production of documentary evidence. Offers with price variation clause will be out rightly rejected.

8. E.M.D.:

Offer shall be accompanied by EMD for an amount of **Rs. 38,170.00 (Rupees Thirty-Eight Thousand One Hundred Seventy Only)**. EMD shall be by way of a Demand Draft drawn in favour of "Uranium Corporation of India Limited" payable at SBI Pulivendula Branch (**Code No. 0989**). No cash or cheque in any form will be accepted as earnest money. No interest will be paid on the earnest money deposit. Tenders received without earnest money deposit will be summarily rejected. **Return of earnest money:** The earnest money of successful Tenderer will be adjusted into security deposit after signing of contract agreement. The earnest money of unsuccessful Tenderers will be returned within 01 (one) month after finalizing L1 party of the work and after getting written request thereon.

The units registered under "Single Point Registration Scheme of NSIC"/ "MSME" are eligible to get the only benefit of issue of Tender document (if any) & EMD at free of cost. Bidders registered as manufacturers in the specific category items/ / Service providers in the manpower services" are only eligible for the benefit of issue of Tender document (if any) & EMD at free of cost.

9. SECURITY DEPOSIT:

The Amount of Security Deposit shall be **03%** of the awarded value of work. Fifty percent of this amount shall have to be deposited as initial security deposit at the time of execution of agreement including the amount deposited as Earnest Money if any.

In addition to the above, further amount to the extent of the **1.5%** of awarded value of the work will be deducted from the running account bills by way of percentage deductions. Such percentage deduction shall **@5%** of the running account bills till the full amount of security deposit is realised / retained by the corporation.

Failure in carry out the awarded work shall entail forfeiture of the security deposit. Security deposit will be refunded without any interest on written request in duplicate to the Engineer-In-Charge after three months of satisfactory completion of the work order. This will be released after successful completion of the work and taking over & on submission of PBG till defect liability period.

10. PENALTY / AGREED LIQUIDATED DAMAGE:

Time shall be the essence of the contract. Bidder shall have to complete the cleaning jobs/ the cold repairing jobs within 01 months from the date of handing over the site to them. If successful Tenderer fails

to execute the order within the agreed stipulated schedule, he shall be liable to pay agreed liquidated damages a sum @ ½ % of the order value per week or part thereof of delay subject to a maximum of 5 weeks. In case of delay beyond 10 weeks, UCIL reserves the right to cancel the order and get the balance work/procurement done through any other agency at your risk and cost.

11. DEFECT LIABILITY PERIOD/ PERFORMANCE BANK GUARANTEE:

No performance bank guarantee is required for this cleaning jobs. But the defect liability period / guarantee period for the repairing jobs shall be six months from the certified date of handing over of job on to the contractor. In case of bad workmanship for the particular Hole repaired with cold welding technique on the spiral heat exchanger. The contractor shall rectify the defects, if any, detected / reported during the guarantee period under this tender from the certified date of completion of work. The contractor shall be responsible to make good and remedy at his own expense within such period, as may be stipulated by the Engineer-in-Charge before the expiry of the guarantee period. .

(13) PAYMENT TERMS:

- Bill (s) will be paid as through Running “ **RA bills**” as mentioned in clause “Bills” of the Scope of Work of contract document.
- Payment will be released after satisfactory completion of the work in all respect and certification by the Engineer-in-charge, UCIL within 30 days of submission of clear bill in triplicate along with tenderer’s letter head. Contractor shall mention actual date of commencement of the work in their bill (s). **Final bill will be released only after submission of Annual Return (Format to be obtained from Site Office - Mill) and work completion letter in duplicate by the contractor.**

(14) VALIDITY OF OFFER:

The offer should remain valid for a minimum period of 180 Days from the date of opening of the tender. The Tenderers shall not be allowed to increase, amend or withdraw his tender within this period and if he does so, he will be liable to take action as against EMD submitted.

(15) PERIOD OF CONTRACT:

The contract period shall remain valid for 12 months from the date of actual commencement of work after successful site mobilization. Site mobilization shall have to be done within 15 days on receipt of LOI or as desired by UCIL Engineer-in-Charge. However, date of actual start of work shall be fixed by UCIL.

(16). EXTENSION OF CONTRACT:

Completion period of this contract is within 12 months from the date of commencement. The tenure/period may be extended for further up to 03 months with additional implications if required after successful completion of initial contract period with same rate, terms & conditions of the contract with mutual consent, if so deemed fit by UCIL and agreed by the contractor.

The tenure/period may also be extended (if the contract value is not consumed due to unforeseen reasons) further up to 12 months after successful completion of initial contract period with same rate, terms & conditions of the contract with mutual consent, if so deemed fit by UCIL and agreed by the contractor. If so happens contractor shall have to work on the same terms & conditions and price of the contract without any escalation of prices.

The completion schedule shall be suitably extended due the following reasons:

- i) Delay in providing fronts by UCIL, for undertaking the work
- ii) Any suspension order given by UCIL under
- iii) Any occurrence of Force Majeure as provided in tender

(17) VARIATION IN QUANTITY OF ITEMS:

Variation in quantity of items mentioned under scope of work: The quantities mentioned against individual items are tentative. The actual quantities of individual items may vary (from those indicated in the tender documents due to actual conditions of the site or due to other reasons) to any extent, keeping the actual value of total work done well within ± 10% on the contract sum or work order value. The contractor shall carry out all work up to total variations of ± 10% on the contract sum or work order value.

value and all tendered rates shall remain firm within this limit. Any individual item may vary to any extent and be excluded altogether.

(18) Subletting of contract:

Subletting of the contract in any form is not allowed .

(19) Evaluation of tender:

- i. Bidder has to quote for all the tendered line items .
- ii. If any bidder has not quoted for any of the tendered line items, his bid may be rejected for consideration of L1 (UCIL has the right to reject the price bid even after their bid is technically qualified)
- iii. Also, If any bidder has quoted abnormally low than our estimation and there by unable to provide the proper justification in the financial breakup, then their price bids may be liable for rejection (UCIL has the right to reject the price bid even after their bid is technically qualified)
- iv. If any bidder's price part is rejected, then the next successful lowest quoted bidder's price part will be considered for evaluation.
- v. Overall L1 amount will be considered as L1 price.

(20) Awarding of tender:

- i. Final Order/contract will be awarded to the overall lowest and Successful L1 Bidder after evaluation.
- ii. Order will be placed on a single bidder who had quoted for all the items and stood at overall L1 (Lowest) amount including all.

Disclaimer/अस्वीकरण
