1. The Bidder must have experience in similar nature of works in last seven years to any Central / State Govt Organization / PSU / Public Listed Company ending last day of month previous to the one in which applications are invited should be either of the following :-

- a) One similar nature of work not less than **Rs. 34.64** lakh i.e.80 % of the estimated value of the work or
- b) Two similar nature of work not less than **Rs. 21.65** lakh each i.e.50 % of the estimated value of the work or
- c) Three similar nature of work not less than **Rs. 17.32** lakh each i.e. 40 % of the estimated value of the work.

2. Minimum average turnover of **Rs. 12.99 Lakh** i.e. 30 % of the estimated value of the work for last 3(three) financial years and submission of duly audited copy of Profit & Loss account and Balance sheet of financial years 2020-21, 2021-2022 & 2022-23 by Chartered Accountant.

3. The Bidder shall submit registration copies of PAN, GST, MSME/NSIC, PF, ESIC and Income Tax Return Statement.

4. Similar Works means- **Deployment of Manpower / Civil maintenance Work** with Govt. / PSU / Public Limited Organization / Private Limited Organization." The contractor will have to submit copy of the work order as well as the completion certificate from the concern department in support of their experience/ credential.

**5. GEOGRAPHIC PRESENCE:** Office registration certificate: Registered office or at least one of the registered branch office of the bidder shall be located and registered within the geographical limits of Dist - East Singhbhum, Jharkhand state where the services needs to be provided. Documentary evidence must be provided in the form of Municipality trade licence or other such documents as per the following which satisfies as a proof of having the office establishment.

A) Trade licence issue by the local authority in the name of the Firm or

B) Landline phone number in the name of the Firm or

C) Electricity bill for last one year in the name of the Firm or

D) GSTIN registration or

E) Udyam /MSME /Udyog Aadhaar certificate.
