**Expression of Interest for Selection of Service Provider to Run Mobile Medical Units (MMU) and Reporting Services (e – Clinic & Mobile Van) for villagers under Corporate Social Responsibility (CSR) to nearby villagers of operating mines of UCIL.**

Uranium Corporation of India Limited is a Public Sector Enterprise under the Department of Atomic Energy with a special standing at the forefront of Nuclear Power cycle.

UCIL invites Expression of Interest (EOI) from the various NGOs/Pvt. Hospitals/Societies/ Registered Companies /Trusts for strengthening of public health facilities in rural and remote areas of its operating mines/units by Integrated Medical Checkups, Diagnostics and Referrals to the Government Hospitals by providing fixed day village camp services for a period of 1 (One year) from the date of the award of the contract and further extendable on the basis of the performance and mutual consent of both the parties. Scope of basic services is to provide health camps in the field for all working days in a month in the form of village level health camps as per jointly agreed route & site plan.

#### **UCIL Plans to**

Empower underprivileged children, women and other citizens in areas across its operating mines/units in identified regions through relevant reach, rendering healthcare services, hygiene education and innovative healthcare with focused programs under corporate social responsibility (CSR) program at the door steps of the people free of cost to overcome the problems of accessibility and availability of health care facilities and service providers towards preventive cure and wellness.

#### **Objective**

- a. Providing Basic Health Care Services to Underserved villagers and their family in nearby mine areas/operating units of UCIL.
- b. Access to health care and equitable distribution of health services are the fundamental requirements for achieving the corporate social responsibility goal under Health & nutrition category.
- c. Free Medical Checkup in nearby rural areas and basic payment for expert advice at door steps
- d. To detect Prevalent Disease & illness and to take early measures and interventions
- e. To diagnose and refer critical case to medical practitioners
- f. Health Care Education and Hygiene information
- g. The objective of the program is to ensure improved health services reaching the doorsteps of people residing in un-served or underserved surrounding areas.
- h. To bring awareness among women, children and old on healthy living and hygiene issues

- i. To engage in providing essential quality Primary Health Care services to the people with basic primitive diagnostic facilities towards wellness and preventive care.
- j. Preventive Health Care measures
- k. Distribution of Medicines and consumables

### **Project Outline and Operations**

1. Deploy & Operate Medical Units towards screening of patients at various defined location
2. Scheduled Visit at Designated Location in week days
3. Managing Weekly/Monthly/Yearly Routine health checkup.
4. Handle Operational Work towards Execution
  - a. Aligning the Team to reach out the action plan
5. Interface with Doctors
  - a. Arrange up doctors towards diagnostic, review and reporting.
6. Health Awareness and Training
7. Required Medication Dispensing via prescription
8. Performing Necessary Pathology Test with reports reviewed by a pathologist
9. Create e-clinics with necessary available Medical Devices.

### **Health Infrastructure Details Required**

#### Pathology Test

- Include All Present Pathology Test performed for Basic checkup.
  - Blood Group
  - Electrolyte
  - Urea
  - Glucose
  - Lipid Profile, HB1AC and Urine Test to be performed New.
  - CBP
  - CUE

#### Pharmacy

- Provide Basic Medication to the Patient from the Medical Unit

#### Technology Platform

- Platform to comprehensively connect the health information to be shared with the Hospitals and or Doctors for Tele-Diagnostics.
- Managing and Monitoring
- Maintaining Health Records of each and every Person Attending.
- Periodic reviews by Doctors utilizing technology platform.
- Provision of software platform, which would provide necessary preventive care thus reducing the day-to-day appointment of doctors.
- More towards Awareness and Updating at Back Office.
- Providing information to the doctors for their diagnostic. This helps in Monitoring & Evaluation

basic health information on frequent as well as record basis alarming forthcoming health issues if any.

Educational/Awareness Screen

Equipped with Informative Screens to spread the necessary benefits of the schemes from the government and also delivering non-health related information, which the officials would like to deliver to the citizens.

**Areas of Operation:**

The area of functioning for the well-equipped MMU units will be surrounding villages within 5 KM radius of UCIL's operating mines/units. They have to operate as per the route chart given by UCIL/Civil Surgeon.

**Duration of the program:**

The duration of the program will be 1 (One year) from the date of the award of the contract and further extendable on the basis of the performance of MMU and mutual consent of both the parties. **Initial performance will be reviewed for first three months.**

**Eligibility:**

Interested agencies must have the following minimum credentials to qualify for the proposed task-

- a. Agency/firm should have a minimum annual average turnover of Rs. 2.00 crores in the last three financial years (2018-19, 2019-20, 2020-21) in similar type of work. Provisional balance sheet of F.Y. 2021-22 may also be submitted.
- b. Similar type of work means healthcare service/ organizing mobile medical camps in rural areas.
- c. The bidder should not be presently blacklisted by any government agencies/ local bodies.
- d. In case of Consortium, the lead member shall be legally responsible and shall represent all consortium members, if any, in all legal matters. Eligibility of lead member shall be considered for evaluating the eligibility of the consortium. In other words lead member should have qualified in all the eligibility parameter on his own strengths.

**Essential requirements/norms to be followed for one MMU:**

**1) Manpower- (to operate two routes daily)**

MO (MBBS only, preferably women)	Two
GNM:	Two
Lab Technician:	Two
Pharmacist cum Administrative Assistant:	Two
Driver cum Support Staff:	Two

- 2) Medicine/other equipment:** Essential medicines shall be supplied to the patients / beneficiaries attending the clinic. The registration of patients, supply of medicines and maintenance of clinic attendance, drug and other relevant registers shall be done by the agency & it will have to keep essential equipment in the Mobile Van.

- 3) Mobile Van with driver – 02 Numbers, to operate two routes daily.**

- 4) Communication/Tracking Position:** Communication tools like mobile or wireless sets should

be available in the unit to keep track of the MMU positioning in case of emergencies. The agency will be required to keep track and report to the societies on a daily basis.

- 5) **Publicity:** Agency will take necessary steps to ensure wide publicity prior to the visit of MMU in a particular area so that larger population can get services.
- 6) **Placement/Night halt:** Mobile Medical Units should always be in running condition and should be placed at the nearest health facilities in the respective functioning areas of UCIL or under the supervision of District Health Society of the concerned district.
- 7) The agency participating in the EOI should furnish the following:
  - I. Details of their past work in similar field
  - II. Profile of Doctors engaged / proposed to be engaged
  - III. Work Experience with government bodies and related organization for similar type of Tele-diagnosis or Tele Health Screening/Monitoring work utilizing ICT platform.
  - IV. Additionally, the agency will review the following format without giving any cost & suggest any modifications.

**Project Agreement to be executed with Vendor/Service Provider:**

1. All notices or communications to be given in email/writing
  - a. Communication Process Agreed by UCIL and Vendor
2. This Body shall be governed by and interpreted in accordance with Indian Law and shall be subject to the exclusive jurisdiction of the courts at Jamshedpur
3. An agreement would be signed between UCIL and Vendor towards working terms for the Health Care services.
  - a. Medico Legality issues and Scenarios if Any to be handled by Vendor
  - b. Failure of Services and Up time Planning
  - c. Monthly Updates of patient to UCIL
  - d. Uptime of the ICT System
4. Agreement for Project Execution and Extension based on Performance.

**General Instruction**

1. UCIL may issue amendments/corrigendum in the EOI documents at any time during the period between publication of EOI and submission. The Vendor / Service Provider in their own interest are advised to visit the website ([www.ucil.gov.in](http://www.ucil.gov.in)) regularly till the last date of submission of the EOI.
2. Vendor / Service Provider shall have to make Technical Presentation in the committee formed by UCIL and no charges will be paid for same.
3. No charges will be paid to the Vendor / Service Provider for preparation of EOI, submission & other ancillary charges if any on any account borne by the Vendor / Service Provider.
4. Vendor / Service Provider shall give their full address, telephone number, Name of Authorized contact person & email ID.
5. The Service provider shall follow the Service Plan/Route plan/Calendar for MMU as approved by CMO UCIL. It is expected that Sunday will be the day on which no service would require to be provided and the weekly off on Sunday it could be used for maintenance, refilling and data entry purposes. However, the competent authority may declare any other day in the week as "off-day". In exceptional circumstances, the weekly off day can be cancelled by the competent authority.
6. It will be the responsibility of service provider to arrange MMU vehicles along with all the listed equipment, human resources to maintain the MMU operational. All the maintenance cost of equipment as well as vehicles will be borne by the service provider since vehicles and equipment are to be provided by the service provider. The vehicles should not be more than two years old from the date of manufacturer on the day of commencement of service. At no

point of time during the currency of the Service agreement, the vehicle will be more than 5 years old from the date of manufacturer.

7. The Service provider shall comply with all the provisions of Minimum Wages Act and other applicable labor laws. The Service provider shall also comply with all other statutory provision including but not limited to provisions regarding medical education and eligibility criteria of human resources used by the Service provider for providing the services, biomedical waste management, bio safety, occupational and environmental safety.
8. The Service provider shall maintain confidentiality of medical records and shall make adequate arrangement for cyber security.
9. Damages for Mishap/Injury: The purchaser shall not be responsible for damages of any kind or for any mishap/injury/ accident caused to any personnel/property of the Service provider while performing duty in any area. All liabilities, legal or monetary, arising in that eventuality shall be borne by firm/ contractor.
10. The service provider shall follow the standard operating procedures (SOPs) as approved by the Ministry of Health & family welfare / District health officer.
11. UCIL reserves absolute right/discretion to reject any or all the EOI received or invite fresh EOI at any stage or split the work between one or more Vendor / Service Provider as the case may be.
12. This UCIL/EOI/CSR/01/2022-23 is 7 (Seven) page document.

Applying Service Provider should submit documentary evidences in support of all details/ information as above.

The interested Service Provider is requested to send their duly signed proposal in a sealed envelope superscribed with the above EOI No.( i.e **UCIL/ EOI/CSR/01/2022-23**), due date, name and address of Service Provider. The EOI should be addressed to General Manager (Projects- North)/ Nodal officer CSR and may be submitted to Uranium Corporation of India Limited, Turamdih, P.O. UCIL reserves the right to accept or reject any EOI in part or full without assigning any reason whatsoever. **The offer shall be valid for a period of three month from the last date of submission of EOI. Limited enquiry may be issued to short listed qualified service providers as per EOI for submission of their offer in short notice period.**

The decision of UCIL shall be final and binding on all.
