Our Andhra Pradesh unit invites Expression of interest from reputed manufactures (or) their authorized dealers / agents/ distributors / partners who will fulfill and able to supply strong base anionic -Ion exchange resin as per the details given below,

1. Party should be capable of supplying strong base anionic -Ion exchange resin having a polymeric structure of Gel type polystyrene crosslinked with divinylbenzene , a functional group of Pyridinium and the resin's particle size ranging from 750- 1400 micron with a uniformity coefficient of 1.4 (max) for adsorption of Uranium .
2. Party should have supplied the above specified resin of 40m³ in current or last three financial years and should submit supporting documents like purchase order / invoice copies etc.
3. Interested parties having resin as given in above Sl.No.(1) should submit sample resin of 1 kg within the due date of this EOI.
4. Qualifying the party shall be done on the basis of resin having the capability to handle higher bed volume of liquor containing uranium and liquor leaving the resin column with lower concentration of Uranium in barren out and also possessing higher loading capacity of Uranium in resin.
5. Resin which gives highest loading capacity will only be qualified.
